Thence, with said 2.065 acres, passing a 5/8 inch diameter rebar found at 39.69 feet, South 10 degrees 53 minutes 44 seconds West a total distance of 136.84 feet to a 3/4 inch diameter iron pipe found at the Northernmost corner of said 0.06 acres;

Thence, with the Southwest line of said 2.065 acres and the Southwest line of 0.111 acre tract conveyed to Gaines Fields by Official Record 283 Page 2400, South 33 degrees 30 minutes 32 seconds East a distance of 357.93 feet to a 5/8 inch diameter rebar with a plastic cap stamped "WS 7722" found in the line of a 39.214 acre tract conveyed to Ruth A. Gillette by Official Record 426 Page 2389;

Thence, with said 39.214 acres and with a 7.089 acre tract also conveyed to Ruth A. Gillette by Official Record 426 Page 2389, passing a 5/8 inch diameter iron pipe found at the corner of said 7.089 acres at 88.72 feet, South 51 degrees 09 minutes 21 seconds West a total distance of 202.86 feet to a corner near the base of a wooden fence post in concrete, a 5/8 inch diameter iron pipe found bears South 23 degrees 02 minutes 51 seconds East a distance of 0.39 feet from said corner;
