Thence leaving the west line of Section 25, South 80° 26' 01" East a distance of 1054.00 feet to a 5/8" iron pin with a plastic identification cap set being the principal place of beginning of the tract herein described;

- 2. South 79° 34' 43" East, passing a 5/8" iron pin with a plastic identification cap set at 728.72 feet, going a total distance of 758.72 feet to a P.K. nail set in the center of Dearth Road (Township Road 234-B);

Thence along the center of Dearth Road the following two (2) courses:

- 1. South 10° 47' 30" West a distance of 29.25 feet to a railroad spike found, and;
- 2. South 10° 10' 29" West a distance of 50.75 feet to a P.K. nail set;



Thence leaving the center of Dearth Road and with a line through the grantor's property the following two (2) courses:

- 1. North 79° 34' 43" West, passing a 5/8" iron pins with plastic identification caps set at 30.00 feet, 598.73 feet and 1157.76 feet, going a total distance of 1653.63 feet to a 5/8" iron pin with a plastic identification cap set, and;
- 2. North 10° 24' 17" East a distance of 347.92 feet to the principal place of beginning, containing 8.678 acres more or less and being subject to the right of way of Dearth Road (Township Road 234-B) and all other easements of record.
