Situate in the State of Ohio, County of Licking, Township of Etna, being a part of the south half of the Northeast Quarter of Section 13, T-16-N, R-20-W, and being all of the lands of Richard E. and Marilyn K Donley as recorded in O.R. 247/459, O.R. 259/602, & O.R. 357/495, being more particularly described as follows:

Beginning at a 5/8" iron bar found at the southwest corner of the Northeast Quarter of Section 13, in the centerline of Tollgate Road (Township Road No. 163), the southwesterly corner of the Donley lands and the northwesterly corner of the Harold O. and Raymond Ford tract (OR 272/535),
