Situated in the State of Ohio, County of Franklin, City of Columbus, being part of Lots 83, 84 and 85, in Neil Place Addition, as the same is numbered and delineated upon the recorded plat thereof, of record in Plat Book 3, Page 362, Recorder's Office, Franklin County, Ohio as conveyed to Fritz W. and Karina K. B. Harding in Instrument 200811040162128, said Recorder's Office, and being more particularly described as follows:

Beginning at a 1 inch hollow iron pipe found at the northwest comer of Lot 83 and at the intersection of the east right of way of Hunter Avenue (25 feet wide) with the south right of way of Buttles Avenue (70 feet wide);

Thence, along part of the North line of said Lot 83 and part the South right of way of said Buttles Avenue, South 87° 06' 00" East, 34.22 feet to a point;

Thence, across said Lots 83, 84 and 85 and being parallel with the East right of way of said Hunter Avenue, South 03° 21' 00° West, 101.80 feet to an iron pipe set, passing an iron pipe set for reference at 2.00 feet;

Thence, continuing across said Lot 85 and being parallel with the South right of way of said Buttles Avenue, North 87° 06' 00" West, 34.22 feet to an iron pipe set in the West line of said Lot 85 and in the east right of way of said Hunter Avenue;

Thence, along part of the West line of said Lot 85, the West line of said Lots 84 and 83 and part of the east right of way of said Hunter Avenue, North 03" 21' 00" East, 101.80 feet to the place of
